An ordinance to create and establish an annuity or pension plan for the officers and employees of Metamora Township and to authorize the township supervisor and the township clerk to contract, in the name of the township, for such plan; to define those classes of officers and employees who shall be covered by such annuity or pension plan; to set forth the respective per centum shares which Metamora Township and the officers and employees shall contribute to further provide for the deduction of contributions from officers and employees compensation; to establish the time at which existing and future employees shall become eligible for such plan and to further establish the normal retirement date for all employee; to provide a method for noncoverage of an officer or employee of the annuity or pension plan; to set forth a date wherein each person covered under the annuity or pension plan shall have a vested right or interest in such plan; to ratify and confirm the validity of any annuity or pension plan in existence on the effective date of this ordinance; and to repeal all ordinances or parts of ordinances in conflict herewith.

ORDAINS:

SECTION 1

This ordinance shall be known and cited as the Metamora Township Pension Plan Ordinance.

SECTION 2

Pursuant to Public Act 77 of 1989, as amended, the Township of Metamora hereby creates and established a pension plan and program for the pensioning of its offers and employees, and for such purposes, also hereby authorizes the township supervisor and the township clerk to contract, in the name of the township board, with any company authorized to transact such business within the State of Michigan for pensions.

SECTION 3

The pension plans created, established and contracted for under this ordinance shall cover each person within the following classes of officers and employees:

All full-time Police Officers

All members of the township board

All members of the township zoning board

All members of the township planning commission

All members of the township zoning board of appeals

All members of the township board of review

All township building inspectors, plumbing and mechanical inspector

All township employees' who are employed for more than thirty hours per week on a regular basis

All township volunteer firemen

All township volunteer ambulance drivers or attendants

All township police chiefs

All township fire chiefs

SECTION 4

- A. The Township of Metamora shall be permitted to annually contribute up to the maximum per centum of the gross wages for each person within the class of officers and employees enumerated in Section 3 hereof to the extent permitted by Michigan law and the Internal Revenue Code, as amended from time to time. Such contributions shall be secured from the general fund of the township. At the employee's option, each employee can contribute the maximum per centum of their gross wages as permitted by Michigan law and the Internal Revenue Code, as amended from time to time
- B. Each employee who is employed on the effective date of the pension plan shall be eligible for coverage on that day.
- C. Every employee who becomes subsequently employed shall be eligible on the first full day of employment.
- D. All employees will be covered by this pension plan.

SECTION 5

Each person so covered under the pension plan shall have a vested right or interest in such plan immediately.

SECTION 6

The Township of Metamora hereby ratifies and confirms the validity of any pension plan in existence on the effective date of this ordinance.

SECTION 7

This ordinance shall take effect on the date of its publication. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
