RESOLUTION ADOPTING METAMORA TOWNSHIP POLICE DEPARTMENT MILLAGE RENEWAL BALLOT LANGUAGE

WHEREAS, the Metamora Township Board wishes to provide the citizens of Metamora Township continued police protection through the renewal of the previously authorized Police Millage; and

WHEREAS, townships may provide for the provision of policing services, as authorized by MCL 41.806: and

WHEREAS, townships may impose and levy ad valorem property taxes to finance lawful public services, as authorized by the Michigan Constitution of 1963 and other laws; and

WHEREAS, the Metamora Township Board wishes to renew at a reduced rate of 2.1793 mills of the previously authorized Metamora Township Police Millage;

NOW, THEREFORE, BE IT RESOLVED that the Metamora Township Board, Lapeer County, approves the following millage ballot question language and directs the Clerk to submit it to be placed on the August 2, 2016, election ballot.

> METAMORA TOWNSHIP POLICE MILLAGE RENEWAL METAMORA TOWNSHIP BALLOT PROPOSAL

Shall the previously authorized millage increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution on general ad valorem taxes within Metamora Township, Lapeer County, be renewed as presently reduced by the required millage rollbacks at the rate of 2.1793 mills (\$2.17 per \$1,000 of taxable value) for the period 2016-2025 inclusive, for a continuation of the current level of police protection by the Metamora Township Police Department; and shall the Township levy such renewal in millage for said purpose, thereby raising in the first year an estimated \$468,600.
