Chairman Nash called the Metamora Township Planning Commission Public Hearing to order at 7:04 p.m. at the Metamora Township Hall, 730 W. Dryden Road, Metamora, Michigan.

The pledge of allegiance was recited.

Chairman Nash announced that this is a public hearing on the application of David and Lannette Amon for special land use approval under Section 1436 for a commercial boarding stable at 2578 E. Sutton. The property in question is zoned A-2 Agricultural and is Parcel No. 44-015-017-007-00. Planner Piggott started his review by saying that this is somewhat of an unusual situation because riding stables are a use which have some protection under the Michigan Right to Farm Act. Mr. Piggott contacted Township Attorney Nolan who submitted an opinion which Mr. Piggott summarized by stating that the Township does not have the authority to deny the request but does have the right to require the applicant to submit a request for a special land use, and the Township can impose minimal conditions so long as they do not conflict with the Generally Accepted Agricultural Management Practices (GAAMPs) or any specific requirements of the Right to Farm Act (RTFA). Mr. Piggott then reviewed his August 3, 2016 analysis.

Member Derderian asked the planner about manure regulations and Mr. Piggott indicated that an applicant can apply to the Michigan Department of Agriculture & Rural Development and submit a Manure Management Plan and the state will review it and determine whether or not it is consistent with the GAAMPs and if it is they will notify the applicant and the township as well.

Chairman Nash acknowledged the applicants in the audience for their comment. David and Lannette Amon stated they have two parcels of property totaling 17 acres and the boarding stable is on their 11½ acre parcel. They average about 15 horses of which half are their own and the other half are boarded horses. They stated they currently have 8 to 15 parking spots and the parking area is gravel/grass. Mr. Amon stated he spreads the manure rather than stockpiling it and further that they do not store horse trailers. They have been conducting this boarding stable business for 17 years. Board discussion.

Planner Piggott reviewed the parking regulations which is one parking space per boarded horse so they would need 7 or 8 parking spaces. Planner Piggott further stated that it is storage, not application, of the manure that has to be 250 feet from a property line but also that it cannot be a nuisance.
