Motion by Derderian, supported by Bedford, to not approve the Third Amended Interlocal Agreement-Lapeer County Emergency Medical Service Authority:

At a regular meeting of the Metamora Township Board on February 13, 2017 at 7:00 p.m. in the Metamora Township Hall, 730 W. Dryden Road, Metamora, Michigan, the Board took up consideration of the request of the Lapeer County EMS Authority for the review and approval of the proposed "Third Amended Interlocal Agreement – Lapeer County Emergency Medical Service Authority," discussion was had, and Trustee Derderian moved that the Metamora Township Board NOT APPROVE the "Third Amended Interlocal Agreement – Lapeer County Emergency Medical Service Authority," for the following reasons, among others:

- 1) The Amendment is too narrowly focused and does even attempt to make necessary structural change to the Board that would make all Members equal. For example:
 - It is fundamentally unfair to Metamora Township to be part of an Authority with a 7 member Board, where two participating municipalities are guaranteed places on the Board where the others are not. *Metamora Township questions why paragraph 3 of the Third Amended interlocal Agreement (which was left unchanged) at this time this continues to assign permanent seats to North Branch Township and Imlay City.* There may have been historical reasons for why these municipalities were granted permanent places on the Board, but we can see no legitimate reason moving forward with an Authority, fully funded by all of the taxpayers of Lapeer County, why guaranteed preferential treatment would continue for just two municipalities. To maintain its existence (and ability to keep 100% of its assets, the new ambulance service, moving forward, simply needs to satisfy North Branch Township, Imlay City, and 3 other municipal Board members, period.

2) The Amendment proposes to change paragraph 11 in a way that harms Metamora Township and other Member municipalities by making termination or withdrawal of a Member futile:

- There would be no point in leaving the Authority, even for a good and legitimate reason, since the Authority would retain Metamora Township's share of the assets indefinitely. Under the new Amendment, for as long as the Authority remains in operation and is not dissolved, Metamora would have no right to receive its proportional distribution of the assets as was previously allowed. The Authority will be empowered to keep Metamora Township's money so long as it exists regardless of whether Metamora remains a member of the Authority or not. This is an unacceptable amendment in the eyes of Metamora Township. This new provision appears designed to effectively hold member municipalities off during the life of the Authority and subject to the vote of 5 of the 7 members that are on the Board at any given time (which again relates back to the first issue raised in objection).
- 3) The Amendment proposes to add a new paragraph 12, which again is viewed as infringing further on the rights of member municipalities and is fundamentally unfair. The new paragraph 12 continues to perpetuate the 7 member Board of Directors. A vote of a super-majority (5) is required from the Board for dissolution. Under this proposal, a majority of total Authority members could wish to dissolve the Authority, but if those general members do not have sufficient representation on the Board, their wishes may not matter. Again, the only vote that matters under this Amendment is a vote of the 7 member Board, with 2 seats guaranteed to North Branch Township and Imlay City.
