Township Business:

Keith Rumbold from the Lapeer County EMS introduced Tom Youatt, a board member of the LCEMS to speak to the Board. Mr. Youatt explained to the Board that before the millage was passed they used assessment money that was paid from all participating townships to keep the LCEMS operating. In 2016 they had to double the assessment to 6% to keep them operating until the Election for the Millage in November was voted on. They have made a commitment to put a base in Metamora so the residents have more response from them and they are diligently working on making this happen. Mr. Youatt stated that he does understand the Metamora Township Boards position on why they have not paid the 2016 assessment because of receiving very little service from the LCEMS. Supervisor Best stated that Metamora Township has had Medstars Ambulance Service back then and Metamora Township still only has Medstars Ambulance service today even after the millage has passed. Mr. Youtt then asked if the Metamora Township Board would please reconsider their position on paying this bill as we all move forward.
