A. Victory Trailer Sales Revised Site Plan.

ROWE's 7/5/17 Memo and the revised drawing were reviewed. Planner Piggott relayed that the revised site plan meets all the requirements of the previously approved special land use permit, that it showed the additional display area as required, and provided the required information on the drainage and detention pond, but the problem is with the storm water calculations. The Township Engineer reported he didn't think the detention pond could hold the storm water. Discussion among Board Members and Mr. Hettinger regarding drainage and detention pond. Minor grading in the display area is required for drainage as well as uncovering and cleaning out the drainage pipe on the property. Township Engineer Mike Carpenter and applicant's engineer, Cory Mabery from Davis Land Surveying, to review calculations again. Discussion on the site plan drawing being difficult to read as several generations of the drawing had been revised and it was suggested to the applicant that if any future amendments to the site plan are requested that a new site plan he prepared.

The lane is now under construction. Board discussion. ROWE has now taken over the duties of the Planning Coordinator for final zoning approval and Mr. Piggott stated he viewed the Dollar General site before tonight's meeting. The site is in compliance except for lack of curb stops on the parking lot facing the south and the ratio of trees is off. Discussion regarding plants. ROWE is working with Dollar General for final zoning approval. No final occupancy permit will be issued until MDOT is satisfied.
