Chief Mallett went over the police report with the Board. He stated also that the Shop with a Hero will be on December 12, 2017.

Township Business:

Trustee Derderian made a motion to consider impoving Article 12A of Metamora Township Zoning Ordinance as follows:

Motion by Derderian, supported by Bedford regarding Zoning Ordinance Article 12A. In 2016, the Township Board enacted an new zoning ordinance provision codified as Article 12A. The purpose of the amendment was to provide a basis for considering applications for natural resource extraction use in light of the 2011 amendment of the Zoning Enabling Act (the amendment is referred to in this motion as "Article 12A").

Article 12A was challenged in the Circuit Court, and was upheld as being valid by the Circuit Court judge. However, in the process of the challenge, certain issues relating to Article 12A were identified.

Considering that Article 12A was upheld by the Circuit Court, the Township Board believes that it is fully valid as written. Such determination by the judge does not prevent the opposing parties in the case from appealing or otherwise attacking Article 12A. However, the Township Board believes that, if there are improvements that can be made to the ordinance as pointed out during the litigation, there is little reason not to consider making them in the interest of the public and for the benefit of all parties interested in the subject matter of Article 12A. It is the position of the Township that it would promote good public policy for the Planning Commission to deliberate and make a recommendation to the Township Board on addressing issues that have been identified regarding Article 12A that might allow all parties to avoid or reduce further litigation and promote the public interest.

Therefore, the Planning Commission, with the assistance of legal counsel for the Township, is directed to deliberate issues that have been identified in Article 12A during Circuit Court litigation, conduct a public hearing in accordance with the Michigan Zoning Enabling Act, and make a recommendation to the Township Board on proposed amendments to Article 12A intended to clarify and assist in avoiding or reducing further litigation and promote the pubic interest.
