Part II of Township Ordinance Article 12A for the zoning approval applications - Proposal by the GBQ Company

Special Counsel Gerry Fisher explained to the Board about the company GBQ and explained why the "need" analysis is required. The Township's special legal counsel and AAOM's attorney, Michael Hindelang disagreed on things, but the Township's legal counsel indicated that any delay in processing the "need" analysis is attributable, at least in part, by the fact that the timing of the filing of the new AAOM application was a big surprise to everyone, but AAOM. Special counsel-Fisher explained that the credible "need" analysis is very important under earlier law in Michigan, and that the materials submitted by AAOM in its application did not fully answer the necessary questions. Mr. Fisher also stated that it would be important for members of the public, that a careful analysis of the application be undertaken. In other words, an independent analysis of "need", performed by a neutral expert, is required, and should be desired by everyone involved.

Motion by Derderian, supported by Bedford to approve the proposal submitted by GBQ, to perform the "need" analysis required in Part II of Township Ordinance Article 12A for the zoning approval application submitted by AAOM, at an estimate of \$17,000 to \$24,300.
