## News from the Treasurer – Summer Taxes 2021

Taxes are payable July 1<sup>st</sup>, 2021 thru September 14<sup>th</sup>, 2021 without penalty. After September 14<sup>th</sup>, an additional 1% penalty will be added until February 14<sup>th</sup>, 2022 on any **unpaid** balance. After February 14<sup>th</sup>, 2022, an additional 3% penalty will be added until February 28<sup>th</sup>, 2022. March 1<sup>st</sup>, 2022 all delinquent taxes are sent to the Lapeer County Treasurer at 255 Clay Street, Suite 303, Lapeer, MI 48446. When paying your summer taxes for 2021, please include the bottom portion of your tax bill with your payment. Make Checks payable to **Metamora Township**. Include your property number and current phone number.

- Partial payments are accepted.
- Payments can be made in person or by visiting our website at [metamoratownship.com](http://metamoratownship.com). There is a 3% fee for credit card payments. There is a smaller fee associated with e-checks.
- Payments can be dropped off in our BLUE drop box near the front door anytime.

## Disabled Veteran's Exemption Information



If you qualify for the disabled Veteran's Exemption, please make sure to turn in the proper paperwork in to our office as soon as possible in order to be exempt for the 2021 tax season. You must be

**100% disabled to qualify.**

## Summer Deferment

You can also research article under MCL 211.51 & Act 24 of 2005 section 51, property taxpayers may defer until February 14, 2022 without penalty or interest, the due date of the summer taxes on their homestead. If interested, please visit our website @ [metamoratownship.com](http://metamoratownship.com) to determine if you qualify. If you qualify, please reach out to the Township Treasurer for the proper form, which must be completed and filed with the Treasurer prior to September 14, 2021 each year to receive the deferral.
